

## Apalachicola Bay System Initiative Community Advisory Board Outreach & Community Engagement Subcommittee Meeting – 2 March 2021

Part of the charge for all Members of the Community Advisory Board is to determine what each of them can do to inform people within their sphere of influence about ABSI and help tie ABSI tightly and positively to the community. Members are ambassadors for ABSI to bridge the gap between ABSI (academia) and the Franklin County community, some of whom within the power base are upset about the FWC approved Bay closure. While there will always be criticism and conspiracy theories, the members should be primed to run interference on behalf of ABSI, answering people's questions, and encouraging them to sign up for the newsletter.

### **Feedback Discussion Following Feb. 24th CAB Meeting**

- Received little feedback – all members noted that the rest of the Board seems pleased that outreach opportunities have increased over the past couple of months

### **March 2021 Newsletter**

- Mahood has drafted March Newsletter. Waiting on finalization of science update from ABSI researchers
- *Mahood* – charged to send Newsletter to subcommittee members by the end of the week for review, with goal to post and email out the following week

### **Apalachicola City Commission**

- Grove provided a brief review of commission meeting
  - It went well, the Commissioners seemed to appreciate an update on the project's progress
  - All subcommittee members agreed to schedule regular updates from the ABSI team with the Commissioners

### **Franklin County Commission**

- O'Connell – confirmed with Commissioner Jones that Sandra could present at the March 16<sup>th</sup> Commission meeting (10-15 min presentation).
- *Mahood* – charged with confirming date with Sandra and coordinating meeting information

### **WFSU Perspectives Review**

- Ackerman and other subcommittee members believe it went well
- Mahood added link of recording to the ABSI website, in an effort to continue increasing traffic
- Hanson and Grove noted that Bloomberg News listened in and contacted additional CAB members for information

### **ANERR's SciCafé and Symposium Reviews**

- Grove stated that the SciCafé episode that featured Sandra and the ABSI project had 106 people register for the event, and 62 attendees from various stakeholder groups (fishermen, business owners, state agencies, NGOs, etc).
- Mahood noted that after the SciCafé event, the ABSI newsletter had 5 new subscribers the same day
  - Mahood added link to this recording on the ABSI website
- All subcommittee members noted that the Symposium was very informative, well-timed, and helpful to help other scientists and the community see all the research currently being conducted in and around the Bay.
  - Mahood added links to the Symposium recordings on the ABSI website

## Media Distribution Plan

- Mahood provided update on the social media aspect of media distribution
  - For each newsletter and important ABSI documents, Mahood publishes on both the Florida State University Coastal and Marine Laboratory's Facebook and Twitter feeds.
  - She has a working relationship with Michael Allen from Oyster Radio, Petra Shuff from Wakulla Chamber of Commerce, and Lisa Munson from Carrabelle Chamber of Commerce. These three organizations regularly share out ABSI based information.
  - Grove regularly shares information to the Apalachicola National Estuarine Research Reserve (ANERR), Focus on Franklin County; Ackerman shares via Apalachicola Riverkeeper; and Hanson shares via Wakulla Citizens
  - *Mahood* – charged to ask Commissioner Jones to share ABSI information on his page as well
- Not much distribution has occurred via local newspapers -- The St. Joe Star and The Apalachicola Times

## Public Workshops

- *All members* – began brainstorming public groups to present to
  - Decided to first aim for a public workshop with the SGI Civic Club.
    - Tentatively aiming for their April 21<sup>st</sup> meeting
      - *Mahood* – charged with communication w/O'Connell to solidify date and time
      - Committee members noted that Joel Trexler, FSUCML Director and ABSI Project Leader, could possibly present at this meeting to take the presentation burden off Brooke's shoulders. *Mahood* – charged with asking Trexler/Brooke about future presentation duties
    - O'Connell also offered to put a blurb about ABSI in the SGI Civic Club newsletter.
      - *Mahood* – charged with creating blurb and sending to O'Connell within the next two weeks
- *All members*– charged to continue brainstorming on collaborative Google Docs list

## March 29<sup>th</sup> Oystermen's Workshop

- Mahood reviewed Oystermen's Workshop details with the committee.
  - She has contacted the oystermen from the first workshop and confirmed their attendance/interest in this upcoming one.
  - She will email out the Workshop agenda within the week

### **Additional Items or News**

- Hanson summarized a current, collaborative StoryMap project between ABSI and Pew Charitable Trusts. This StoryMap will highlight historical oyster landings in the Apalachicola Bay area. The intent is to create a presentation that is functional to present at public workshops, symposiums, and more.
  - This project is aimed to be complete by April/May. Hanson suggested presenting it at a CAB meeting for member feedback
- Mahood also noted a new infographic on Apalachicola ecosystem services is in the works
