# Apalachicola Bay System Initiative Community Advisory Board Outreach & Community Engagement Subcommittee Meeting Minutes – 02 November 2022

# **Public Meetings Debrief**

- Oystermen's Workshop
  - Committee was pleased that the meeting was conversational rather than confrontational
  - o Anyone attending is always a win!
  - Need to look for ways to engage the more oystermen and younger generations of oystermen and watermen. Those are the people that have an opportunity to return to the water.
  - Committee agrees to continue offering opportunities for oystermen and watermen to work with FSU and receive pay (like with the restoration projects)
  - Ackerman notes that there have been historic differences on how decisions should be/have been made in terms of the Bay for decades.
    - Important to continue to let everyone not only feel heard, but be heard

## Community Workshop

- Fuqua notes that the people that attended this workshop were notified via the flyers posted around Apalachicola
  - This is what we will continue to do for the next meeting
- Overall, this workshop was more so a continuation of the oystermen's workshop the night before
- Small groups is not necessarily a bad thing
- Committee agrees to continue initiating one-on-one meetings with local citizens, commission members, watermen, etc.

# General notes

- Betsy Mansfield (Dr. Brooke's post-doctoral student and new committee member) is currently working on approval from FSU to talk to oystermen and watermen
  - Her aim is to gather oral histories of the area as well as opinions on management of the Bay
- Committee agrees that another Community Workshop should be held in early to mid-February. The committee doesn't think there needs to be a separation of Oystermen and Community Workshops anymore – better to have it all in one.
  - At this meeting, provide very brief update on science, ABSI goals for the year, and then conduct an oral survey using the public questionnaire developed in May 2022
  - Mahood will ask Jeff Blair for date availability, as he will facilitate the meeting once again

## Franklin County Commission Debrief

- Brooke's presentation went very well. The Commission was very receptive to the ABSI updates and Commissioner Boldt asked for a published data summary report.
  - o *Brooke* will draft summary report.
- The Commission also suggested conducting a roundtable about the oyster fishery and status with NOAA, ANERR, FWC, and ABSI

#### **Apalachicola City Commission**

Brooke last presented in May, Grove will schedule a new presentation in early January

Florida Seafood Fest Booth on November 4 – 5, 2022 (Fuqua)

- ABSI will be at the Florida Seafood Fest
  - Fuqua and Mansfield suggested doing informal surveys with local citizens that come by the tent
  - Mansfield suggested using sticky flags on giant ABSI map to allow for informal data collection on where local citizens think the restoration efforts should be concentrated in the Bay
    - These flags could be color-coded by occupation or city, such as Apalachicola, Wakulla, St. George Island, Eastpoint, etc.
    - Mansfield and Fuqua will coordinate and report back to the committee.

Sopchoppy Oyster and Mullet Festival on November 12, 2022 (Fugua)

• Fuqua will coordinate similar informal survey efforts at this festival the following week

# **ABSI Newsletter Review**

• Mahood is drafting newsletter. It will highlight the FAQs as well as the recent reef layer cake deployments. Goal is to send week of Nov.  $7 - 11^{th}$ .

# ABSI Op-Ed

- Committee agrees to create a new Op-Ed or article for early 2023
  - This can highlight ABSI goals for 2023 as well as promote next Community Workshop
- Mansfield and Grove suggest buying ad space in the paper for either next Op-Ed and/or to continue circulating FAQs
- Resko will talk to FWC about submitting next Op-Ed with FWC as the main focus
  - Resko notes that when FWC took Rep. Jason Shoaf out on the boats, he talked about the local community's distrust of FSU. Shoaf pointed out that there has been a lack of communication what FWC is doing.
  - By using FWC as the main content distributor, hopefully this can alleviate some of the bad feelings towards FSU and highlight our collaborations
  - Resko will also send Mahood contact information for Rep. Shoaf's office to ensure his office is always present and aware of CAB meetings

#### **ABSI FAQ Circulations**

- Every Monday, Mahood is posting different ABSI or FWC FAQs.
  - Mahood will send a reminder to committee in order to further distribution on local community pages
- Mahood and Mansfield will look into purchasing ad space for FAQs in The Apalachicola Times paper

- Hanson and Grove will work on draft of CAB Plan Summary
  - Goal is to make overall draft management plan a layman's terms, 2-3 page summary report. This can then be published on website and social media.

# Social Media Mini-Series

- *Mahood, Fuqua, and Mansfield* will meet within the next week to discuss video series. They will then provide schedule and storyboards to Committee.
  - Large focus on FAQs with visuals
  - Highlight tonging efforts and data collection efforts
  - Collaboration with FWC use FWC resources and get footage diving, surveying oyster beds, etc.
- Hanson suggested working with the FSU College of Motion Picture Arts to also do a collaborative project on documenting work in the Bay, current status, etc.
